Synopsis: State budget. Appropriates money for capital expenditures, the operation of the state, K-12 and higher education, the delivery of Medicaid and other services, and various other distributions and purposes. Requires a researcher to execute a data sharing agreement that is approved by the management performance hub to receive access to confidential records. Provides that the auditor of state is also known as the state comptroller. Provides that, after June 30, 2023, the auditor of state shall use the title "state comptroller" in conducting state business, in all contracts, on business cards, on stationery, and with other means of communication as necessary. Establishes the attorney general contingency fee fund. Establishes the: (1) state opioid settlement fund; and (2) local opioid settlement fund; into which funds received from opioid litigation settlements must be deposited. Provides that the office of the inspector general shall provide informal advisory opinions and that the opinions are confidential. Allows the budget committee to submit the budget report and budget bill or bills to the governor on or before the second Monday of January, or the third Monday of January in the year in which a gubernatorial election is held (instead of before that date). Requires the state personnel department to require a contractor, when contracting for health care coverage for state employees, to use value based coverage. Repeals a provision that makes a state general fund appropriation to the board of



trustees of the Indiana public retirement system if the money available in the special death benefits fund is insufficient to pay death benefit claims. Allows the Indiana economic development corporation (IEDC) to certify an applicable tax credit that exceeds the maximum allowable amount after review by the budget committee. Provides that the regional economic acceleration and development initiative program expires June 30, 2026. Specifies that the county or municipality that did not approve the relocation of an outdoor advertising sign is responsible for compensation of the taking of the outdoor advertising sign. Provides that an owner may relocate an outdoor advertising sign that is subject to a pending eminent domain action. Allows an individual to claim an increased exemption amount for a dependent child in the first year in which the exemption amount may be claimed for the child. Reduces the individual income tax rate to 2.9% by 2027 and eliminates all trigger provisions in current law. Establishes the regional public safety training fund. Repeals provisions relating to the establishment of the: (1) Indiana homeland security foundation; (2) Indiana homeland security fund; and (3) fire training infrastructure fund. Allows certain members of the public employees' retirement fund or Indiana state teachers' retirement fund to file an election to begin receiving retirement benefits while holding a position. Changes the state police pre-1987 benefit and supplemental pension benefit calculation from being based on the sixth year of service to the fourth year of service. Repeals the public mass transportation fund. Repeals the financial responsibility compliance verification fund. Changes the number of years of service on which the salary matrix for state police employees is based to 15 years (instead of 20 years). Requires the department of correction to deposit the amount appropriated for the county misdemeanor fund by a county's multiplier. Requires the office of Medicaid policy and planning (office) to: (1) develop a schedule for the review of Medicaid reimbursement rates; and (2) provide a copy of the schedule to the budget committee; not later than November 1, 2023. Creates the residential water testing fund to test the water supply of an individual property owner of an eligible township. Requires the director of the state personnel department to submit a revision or adjustment to a pay plan developed for state employees to the state budget committee for review before the revision may take effect. Provides that the general assembly shall convene: (1) on the second Tuesday after the first Monday in June for the first regular technical session; and (2) on the second Tuesday after the first Monday in May for the second regular technical session. Provides that a technical session is not required to convene if the president pro tempore and the speaker jointly issue an order that convening is not necessary. Requires the general assembly to convene no later than the fourth Monday in January after organization day. Repeals provisions relating to emergency sessions and makes conforming amendments. Recouples the state earned income tax credit qualifications with the federal earned income tax credit qualifications under the Internal Revenue Code as in effect January 1, 2023. Requires a contractor that provides tangible personal property incorporated into real property in a project located in an innovation development district to maintain records of all state gross retail and use tax paid or collected during a state fiscal year. Adds state adjusted gross income taxes paid by an individual who is not an employee with respect to income received for services performed in an innovation development district for purposes of calculating income tax incremental amounts. Establishes the commission on improving the status of children fund to support the staffing and operations of the commission. Provides that a part of state user fees shall be deposited in the Indiana secured school fund. Repeals the distribution schedule for appropriations made for certain child development programs. Requires the department of local government finance to prepare an annual report and abstract concerning property tax data (instead of the auditor of state). Deletes reimbursement rate parameters for reimbursement of managed care organizations under the healthy Indiana plan. Extends the sunset of the collection of hospital assessment fees and health facility quality assessment fees from June 30, 2023, to June 30, 2025. Increases the total number of adult learner students at the Excel Centers for Adult Learners and Christel House DORS centers for whom the school may receive state funding. Establishes the Indiana education scholarship account donation fund to accept donations for



administration of the Indiana education scholarship account program. Repeals the special education fund. Establishes a state tax credit for a taxpayer that makes certain qualified child care expenditures in providing child care to the taxpayer's employees. Extends provisions for the gasoline tax and the special fuel tax rates. Amends a statute concerning powers and duties of a regional water, sewage, or solid waste district established under prior law. Extends the sunset for the invasive species council and fund from July 1, 2023, to July 1, 2031. Prohibits school corporations and charter schools from charging a fee for curricular materials to students. Provides that the parent of a student or an emancipated minor who attends an accredited nonpublic school and who meets financial eligibility requirements may request reimbursement of fees charged for curricular materials. Establishes the curricular materials fund. Requires a county auditor to distribute a portion of revenue received from an operations fund levy imposed by a school corporation located in certain counties to certain charter schools (excludes school corporations that are designated as a distressed political subdivision). Requires charter schools that receive a distribution of tax levy revenue to establish an operations fund and education fund under the same provisions that apply to school corporations. Provides that in order to receive a distribution of tax levy revenue, a charter school must adopt a budget for the school year following a public meeting. Provides funding amounts for schools. Establishes the credential completion grant. Removes pathways for choice scholarship eligibility. Increases the annual income maximum for choice scholarship eligibility. Provides that a school corporation is eligible for an academic performance grant. Provides that state user fees remaining after required distributions shall be distributed to the state general fund (instead of the court technology fund). Makes certain amendments to the juvenile diversion grant program, the juvenile community alternatives grant program, and the juvenile behavioral health competitive grant pilot program (programs). Requires grants for the programs to be administered by the Indiana criminal justice institute in consultation with the juvenile justice oversight committee (oversight committee) and the grant process workgroup created by the oversight committee, taking into consideration the grant program report prepared and submitted to the commission on improving the status of children in Indiana by the oversight committee. Requires the state comptroller to deposit distributions of pro bono legal services fees received from the: (1) clerk of a circuit court; (2) clerk of a city or town court; or (3) Marion County small claims court; in the pro bono legal services fund. Requires the commission for higher education to create a separate higher educational operating funding outcomes based formula (funding formula) for Ivy Tech Community College. Requires, on or before July 1, 2023, budget committee review of all of the funding formulas created and approved by the commission for higher education. Provides that state appropriations may not be used to pay for the administration, operation, or programs of the Kinsey Institute for Research in Sex, Gender, and Reproduction. Provides that the legislative body of a first class city may adopt an ordinance to establish a special assessment district known as an economic enhancement district. Provides certain requirements for the ordinance and imposition of a special assessment. Requires the legislative body of the first class city that establishes an economic enhancement district to establish an economic enhancement district board. Extends the judicial and legislative branch leave conversion pilot program through June 30, 2025. Establishes the northeast Indiana strategic development fund administered by the northeast Indiana strategic development commission. Provides that if the amount of excess combined reserves in 2024 or 2025 exceeds \$3,000,000,000, the amount that exceeds \$3,000,000,000 is transferred to the pre-1996 account. Establishes the regional economic acceleration and development initiative 2.0 fund (READI 2.0). Requires the IEDC to develop a policy for a READI 2.0 program. Provides that money in the READI 2.0 fund may be used to: (1) support the IEDC's READI 2.0 program; and (2) provide grants or loans to support proposals for economic development and regional economic acceleration and development. Establishes the attainable homeownership tax credit for a taxpayer who makes a contribution to an affordable housing organization. Establishes the Medicaid oversight committee. Requires the Medicaid



oversight committee to review, consider, and make recommendations concerning all requests for new services and changes in existing services for the Medicaid program. Provides that unexpended and unencumbered amounts appropriated from the federal economic stimulus fund in the state fiscal year ending before July 1, 2023, do not revert to the state general fund. Provides that unexpended and unencumbered amounts appropriated to the legislative services agency in a state fiscal year ending before July 1, 2024, do not revert to the state general fund. Requires the state comptroller to transfer \$85,000,000 from the tobacco master settlement agreement fund to the state construction fund on July 1, 2023. Appropriates money for various purposes for the state fiscal year ending June 30, 2023. Urges the legislative council to assign to an appropriate interim study committee the task of studying specific issues pertaining to the feasibility of the department of child services contracting with private attorneys to perform legal services and provide representation in certain cases instead of employing staff attorneys within the department of child services for those purposes. Requires the Indiana public retirement system to study and report and present on certain topics to the interim study committee on pension management oversight before November 1, 2023. Establishes the funding Indiana's roads for a stronger, safer tomorrow task force. Makes conforming changes. **(This conference committee report deletes everything from the bill, combines provisions from the house passed budget and senate passed budget, and adds other provisions described above.)**

CONFERENCE COMMITTEE REPORT

MR. SPEAKER:

Your Conference Committee appointed to confer with a like committee from the Senate upon Engrossed Senate Amendments to Engrossed House Bill No. 1001 respectfully reports that said two committees have conferred and agreed as follows to wit:

that the House recede from its dissent from all Senate amendments and that the House now concur in all Senate amendments to the bill and that the bill be further amended as follows:

Delete everything after the enacting clause and insert the following:

SECTION 1. [EFFECTIVE JULY 1, 2023]

(a) The following definitions apply throughout this act:

(1) "Augmentation allowed" means the governor and the budget agency are authorized to add to an appropriation in this act from revenues accruing to the fund from which the appropriation was made.

(2) "Biennium" means the period beginning July 1, 2023, and ending June 30, 2025.

Appropriations appearing in the biennial column for construction or other permanent improvements do not revert under IC 4-13-2-19 and may be allotted.

(3) "Equipment" includes machinery, implements, tools, furniture, furnishings, vehicles, and other articles that have a calculable period of service that exceeds twelve (12) calendar months.

(4) "Fee replacement" includes payments to universities to be used to pay indebtedness resulting from financing the cost of planning, purchasing, rehabilitation, construction, repair, leasing, lease-purchasing, or otherwise acquiring land, buildings, facilities, and equipment to be used for academic and instructional purposes.

(5) "Other operating expense" includes payments for "services other than personal", "services by contract", "supplies, materials, and parts", "grants, subsidies, refunds, and awards", "in-state travel", "out-of-state travel", and "equipment".

(6) "Personal services" includes payments for salaries and wages to officers and employees of the state (either regular or temporary), payments for compensation

1 awards, and the employer's share of Social Security, health insurance, life insurance,
2 dental insurance, vision insurance, deferred compensation - state match, leave
3 conversion, disability, and retirement fund contributions.

4 (7) "State agency" means:

5 (A) each office, officer, board, commission, department, division, bureau, committee,
6 fund, agency, authority, council, or other instrumentality of the state;

7 (B) each hospital, penal institution, and other institutional enterprise of the state;

8 (C) the judicial department of the state; and

9 (D) the legislative department of the state.

10 However, this term does not include cities, towns, townships, school cities, school
11 townships, school districts, other municipal corporations or political subdivisions
12 of the state, or universities and colleges supported in whole or in part by state
13 funds.

14 (8) "Total operating expense" includes payments for both "personal services" and
15 "other operating expense".

16 (b) The state board of finance may authorize advances to boards or persons having
17 control of the funds of any institution or department of the state of a sum of
18 money out of any appropriation available at such time for the purpose of establishing
19 working capital to provide for payment of expenses in the case of emergency when
20 immediate payment is necessary or expedient. Advance payments shall be made by
21 warrant by the state comptroller, and properly itemized and receipted bills or invoices
22 shall be filed by the board or persons receiving the advance payments.

23 (c) All money appropriated by this act shall be considered either a direct appropriation
24 or an appropriation from a rotary or revolving fund.

25 (1) Direct appropriations are subject to withdrawal from the state treasury and for
26 expenditure for such purposes, at such time, and in such manner as may be prescribed
27 by law. Direct appropriations are not subject to return and rewithdrawal from the
28 state treasury, except for the correction of an error which may have occurred in
29 any transaction or for reimbursement of expenditures which have occurred in the
30 same fiscal year.

31 (2) A rotary or revolving fund is any designated part of a fund that is set apart
32 as working capital in a manner prescribed by law and devoted to a specific purpose
33 or purposes. The fund consists of earnings and income only from certain sources
34 or combination of sources. The money in the fund shall be used for the purpose designated
35 by law as working capital. The fund at any time consists of the original appropriation
36 to the fund, if any, all receipts accrued to the fund, and all money withdrawn from
37 the fund and invested or to be invested. The fund shall be kept intact by separate
38 entries in the state comptroller's office, and no part of the fund shall be used
39 for any purpose other than the lawful purpose of the fund or revert to any other
40 fund at any time. However, any unencumbered excess above any prescribed amount may
41 be transferred to the state general fund at the close of each fiscal year unless
42 otherwise specified in the Indiana Code.

44 SECTION 2. [EFFECTIVE JULY 1, 2023]

45
46 For the conduct of state government, its offices, funds, boards, commissions,
47 departments, societies, associations, services, agencies, and undertakings, and
48 for other appropriations not otherwise provided by statute, the following sums
49 in SECTIONS 3 through 10 are appropriated for the periods of time designated

1 from the general fund of the state of Indiana or other specifically designated funds.

2

3 In this act, whenever there is no specific fund or account designated, the
4 appropriation is from the general fund.

22 Included in the above appropriations for house and senate expense are funds for
23 a legislative business per diem allowance, meals, and other usual and customary
24 expenses associated with legislative affairs. Each member of the house is entitled,
25 when authorized by the speaker of the house, to the legislative business per diem
26 allowance for every day the member is engaged in official business. The speaker
27 shall authorize the legislative business per diem allowance to be consistent with
28 law and house rules.

29

30 Each member of the senate is entitled, when authorized by the president pro tempore
31 of the senate, to the legislative business per diem allowance for every day the member
32 is engaged in official business. The president pro tempore of the senate shall authorize
33 the legislative business per diem allowance to be consistent with law and senate rules.

34

35 Each member of the general assembly is entitled, when authorized by the speaker of the
36 house or the president pro tempore of the senate, to the legislative business per diem
37 allowance for every day the member is engaged in official business.

38

39 The legislative business per diem allowance that each member of the general assembly
40 is entitled to receive equals the maximum daily amount allowable to employees of the
41 executive branch of the federal government for subsistence expenses while away from
42 home in travel status in the Indianapolis area. The legislative business per diem
43 changes each time there is a change in that maximum daily amount.

44

45 In addition to the legislative business per diem allowance, each member of the general
46 assembly shall receive the mileage allowance in an amount equal to the standard
47 mileage rates for personally owned transportation equipment established by the federal
48 Internal Revenue Service for each mile necessarily traveled from the member's usual
49 place of residence to the state capitol. However, if the member traveled by a means

1 other than by motor vehicle, and the member's usual place of residence is more than
2 one hundred (100) miles from the state capitol, the member is entitled to reimbursement
3 in an amount equal to the lowest air travel cost incurred in traveling from the
4 usual place of residence to the state capitol. During the period the general assembly
5 is convened in regular or special session, the mileage allowance shall be limited
6 to one (1) round trip each week per member.
7

8 Any member of the general assembly who is appointed by the governor, speaker of
9 the house, president or president pro tempore of the senate, house or senate minority
10 floor leader, or Indiana legislative council to serve on any research, study, or survey
11 committee or commission, or who attends any meetings authorized or convened
12 under the auspices of the Indiana legislative council, including pre-session conferences
13 and federal-state relations conferences, is entitled, when authorized by the legislative
14 council, to receive the legislative business per diem allowance for each day the
15 member is in actual attendance and is also entitled to a mileage allowance, at the
16 rate specified above, for each mile necessarily traveled from the member's usual
17 place of residence to the state capitol, or other in-state site of the committee,
18 commission, or conference. The per diem allowance and the mileage allowance permitted
19 under this paragraph shall be paid from the legislative council appropriation for
20 legislator and lay member travel unless the member is attending an out-of-state
21 meeting, as authorized by the speaker of the house of representatives or the president
22 pro tempore of the senate, in which case the member is entitled to receive:

23 (1) the legislative business per diem allowance for each day the member is engaged
24 in approved out-of-state travel; and

25 (2) reimbursement for traveling expenses actually incurred in connection with the
26 member's duties, as provided in the state travel policies and procedures established
27 by the legislative council.
28

29 Notwithstanding the provisions of this or any other statute, the legislative council
30 may adopt, by resolution, travel policies and procedures that apply only to members
31 of the general assembly or to the staffs of the house of representatives, senate,
32 and legislative services agency, or both members and staffs. The legislative council
33 may apply these travel policies and procedures to lay members serving on research,
34 study, or survey committees or commissions that are under the jurisdiction of the
35 legislative council. Notwithstanding any other law, rule, or policy, the state travel
36 policies and procedures established by the Indiana department of administration
37 and approved by the budget agency do not apply to members of the general assembly,
38 to the staffs of the house of representatives, senate, or legislative services agency,
39 or to lay members serving on research, study, or survey committees or commissions
40 under the jurisdiction of the legislative council (if the legislative council applies
41 its travel policies and procedures to lay members under the authority of this SECTION),
42 except that, until the legislative council adopts travel policies and procedures,
43 the state travel policies and procedures established by the Indiana department of
44 administration and approved by the budget agency apply to members of the general
45 assembly, to the staffs of the house of representatives, senate, and legislative
46 services agency, and to lay members serving on research, study, or survey committees
47 or commissions under the jurisdiction of the legislative council. The executive
48 director of the legislative services agency is responsible for the administration
49 of travel policies and procedures adopted by the legislative council. The state

1 **comptroller shall approve and process claims for reimbursement of travel related**
2 **expenses under this paragraph based upon the written affirmation of the speaker**
3 **of the house of representatives, the president pro tempore of the senate, or the**
4 **executive director of the legislative services agency that those claims comply with**
5 **the travel policies and procedures adopted by the legislative council. If the funds**
6 **appropriated for the house and senate expenses and legislative salaries are insufficient**
7 **to pay all the necessary expenses incurred, including the cost of printing the journals**
8 **of the house and senate, there is appropriated such further sums as may be necessary**
9 **to pay such expenses.**

16 **Each member of the general assembly is entitled to a subsistence allowance of forty**
17 **percent (40%) of the maximum daily amount allowable to employees of the executive**
18 **branch of the federal government for subsistence expenses while away from home in**
19 **travel status in the Indianapolis area for:**
20 **(1) each day that the general assembly is not convened in regular or special session; and**
21 **(2) each day after the first session day held in November and before the first session**
22 **day held in January.**

23

24 **However, the subsistence allowance under subdivision (2) may not be paid with respect**
25 **to any day after the first session day held in November and before the first session day**
26 **held in January with respect to which all members of the general assembly are entitled**
27 **to a legislative business per diem, and the subsistence allowance under subdivision (3)**
28 **may not be paid to a member after the final recess day in April with respect to any**
29 **day in which the chamber in which the individual is a member meets as a body or in**
30 **any period in which the chamber is in recess for less than six (6) consecutive days.**

31

32 **The subsistence allowance is payable from the appropriations for legislators' subsistence.**

33

34 **The officers of the senate are entitled to the following amounts annually in addition**
35 **to the subsistence allowance: president pro tempore, \$7,000; assistant president**
36 **pro tempore, \$3,000; majority floor leader, \$5,500; assistant majority floor leader(s),**
37 **\$3,500; majority floor leader emeritus, \$2,500; majority caucus chair, \$5,500;**
38 **assistant majority caucus chair(s), \$1,500; appropriations committee chair, \$5,500;**
39 **tax and fiscal policy committee chair, \$5,500; appropriations committee ranking**
40 **majority member, \$2,000; tax and fiscal policy committee ranking majority member,**
41 **\$2,000; majority whip, \$4,000; assistant majority whip, \$2,000; minority floor leader,**
42 **\$6,000; minority leader emeritus, \$1,500; minority caucus chair, \$5,000; assistant**
43 **minority floor leader, \$5,000; appropriations committee ranking minority member,**
44 **\$2,000; tax and fiscal policy committee ranking minority member, \$2,000; minority**
45 **whip(s), \$2,000; assistant minority whip, \$1,000; assistant minority caucus chair(s),**
46 **\$1,000; agriculture committee chair, \$1,000; natural resources committee chair,**
47 **\$1,000; public policy committee chair, \$1,000; corrections and criminal law committee**
48 **chair, \$1,000; civil law committee chair, \$1,000; education and career development**

8 committee chair, \$1,000; and ethics committee chair, \$1,000. If an officer fills more
9 than one (1) leadership position, the officer shall be paid for the higher paid position.

11 Officers of the house of representatives are entitled to the following amounts annually

Of the above appropriations, \$4,000,000 each fiscal year shall be used to support robotics programs, as defined by IC 20-20-45.5, and the Indiana Bar Foundation's We the People programs at school corporations and charter schools.

Of the above appropriations, \$300,000 each fiscal year shall be used to partner with the commission for higher education to provide professional development and technical assistance to schools that pilot the transitions math course for students transitioning from secondary to post-secondary education.

5 SECTION 14. [EFFECTIVE JULY 1, 2023]

7 The budget agency, under IC 4-10-11, IC 4-12-1-13, and IC 4-13-1, in cooperation
8 with the Indiana department of administration, may fix the amount of reimbursement
9 for traveling expenses (other than transportation) for travel within the limits of
10 Indiana. This amount may not exceed actual lodging and miscellaneous expenses
11 incurred. A person in travel status, as defined by the state travel policies and
12 procedures established by the Indiana department of administration and the budget
13 agency, is entitled to a meal allowance not to exceed during any twenty-four (24)
14 hour period the standard meal allowances established by the federal Internal Revenue
15 Service.

16
17 All appropriations provided by this act or any other statute, for traveling and
18 hotel expenses for any department, officer, agent, employee, person, trustee, or
19 commissioner, are to be used only for travel within the state of Indiana, unless
20 those expenses are incurred in traveling outside the state of Indiana on trips that
21 previously have received approval as required by the state travel policies and procedures
22 established by the Indiana department of administration and the budget agency. With
23 the required approval, a reimbursement for out-of-state travel expenses may be granted
24 in an amount not to exceed actual lodging and miscellaneous expenses incurred.
25 A person in travel status is entitled to a meal allowance not to exceed during any
26 twenty-four (24) hour period the standard meal allowances established by the federal
27 Internal Revenue Service for properly approved travel within the continental United
28 States and a minimum of \$50 during any twenty-four (24) hour period for properly
29 approved travel outside the continental United States. However, while traveling
30 in Japan, the minimum meal allowance shall not be less than \$90 for any twenty-four
31 (24) hour period. While traveling in Korea and Taiwan, the minimum meal allowance
32 shall not be less than \$85 for any twenty-four (24) hour period. While traveling
33 in Singapore, China, Great Britain, Germany, the Netherlands, and France, the minimum
34 meal allowance shall not be less than \$65 for any twenty-four (24) hour period.
35

36 In the case of the state supported institutions of postsecondary education, approval
37 for out-of-state travel may be given by the chief executive officer of the institution,
38 or the chief executive officer's authorized designee, for the chief executive officer's
39 respective personnel.

26 the proceeds derived from the settlement of any claim for the loss shall be deposited
27 in the state treasury, and the amount deposited is hereby reappropriated to the
28 institution or department for the purpose of replacing the loss. If it is determined
29 that the loss shall not be replaced, any funds received from the settlement of a
30 claim shall be deposited into the state general fund.

31

32 SECTION 19. [EFFECTIVE JULY 1, 2023]

33

34 If an agency has computer equipment in excess of the needs of that agency, then
35 the excess computer equipment may be sold under the provisions of surplus property
36 sales, and the proceeds of the sale or sales shall be deposited in the state treasury.
37 The amount so deposited is hereby reappropriated to that agency for other operating
38 expenses of the then current year, if approved by the director of the budget agency.

39

40 SECTION 20. [EFFECTIVE JULY 1, 2023]

41

42 This act does not authorize any rehabilitation and repairs to any state buildings,
43 nor does it allow that any obligations be incurred for lands and structures, without
44 the prior approval of the budget director or the director's designee. This SECTION
45 does not apply to contracts for the state universities supported in whole or in part
46 by state funds.

48 SECTION 21. [EFFECTIVE JULY 1, 2023]

49

1 If an agency has an annual appropriation fixed by law, and if the agency also receives
2 an appropriation in this act for the same function or program, the appropriation in
3 this act supersedes any other appropriations and is the total appropriation for the
4 agency for that program or function.

5
6 SECTION 22. [EFFECTIVE JULY 1, 2023]
7

8 The balance of any appropriation or funds heretofore placed or remaining to the
9 credit of any division of the state of Indiana, and any appropriation or funds provided
10 in this act placed to the credit of any division of the state of Indiana, the powers,
11 duties, and functions whereof are assigned and transferred to any department for
12 salaries, maintenance, operation, construction, or other expenses in the exercise
13 of such powers, duties, and functions, shall be transferred to the credit of the
14 department to which such assignment and transfer is made, and the same shall be
15 available for the objects and purposes for which appropriated originally.

16
17 SECTION 23. [EFFECTIVE JULY 1, 2023]
18

19 The director of the division of procurement of the Indiana department of administration,
20 or any other person or agency authorized to make purchases of equipment, shall not
21 honor any requisition for the purchase of an automobile that is to be paid for from any
22 appropriation made by this act or any other act, unless the following facts are shown
23 to the satisfaction of the commissioner of the Indiana department of administration or
24 the commissioner's designee:

25 (1) In the case of an elected state officer, it shall be shown that the duties of the
26 office require driving about the state of Indiana in the performance of official duty.

27 (2) In the case of department or commission heads, it shall be shown that the statutory
28 duties imposed in the discharge of the office require traveling a greater distance
29 than one thousand (1,000) miles each month or that they are subject to official duty
30 call at all times.

31 (3) In the case of employees, it shall be shown that the major portion of the duties
32 assigned to the employee require travel on state business in excess of one thousand
33 (1,000) miles each month, or that the vehicle is identified by the agency as an integral
34 part of the job assignment.

35
36 In computing the number of miles required to be driven by a department head or an
37 employee, the distance between the individual's home and office or designated official
38 station is not to be considered as a part of the total. Department heads shall annually
39 submit justification for the continued assignment of each vehicle in their department,
40 which shall be reviewed by the commissioner of the Indiana department of administration,
41 or the commissioner's designee. There shall be an insignia permanently affixed on
42 each side of all state owned cars, designating the cars as being state owned. However,
43 this requirement does not apply to state owned cars driven by elected state officials
44 or to cases where the commissioner of the Indiana department of administration or
45 the commissioner's designee determines that affixing insignia on state owned cars
46 would hinder or handicap the persons driving the cars in the performance of their
47 official duties.

32 tax withholding or composite filing.

10 twenty million dollars (\$20,000,000) with interest. **Notwithstanding the date on which a tax credit is**
11 **awarded under this chapter, any repayment of any part of a credit awarded under this chapter shall**
12 **be deposited in the state general fund.**

13 (b) Notwithstanding subsection (a), the corporation may exclude from its agreement entered into under
14 section 17 of this chapter a repayment provision for any portion of the credit if the award is for a qualified
15 redevelopment site subject to a proposal that will result in a qualified investment of at least one hundred
16 million dollars (\$100,000,000).

17 (c) If the corporation enters into an agreement with a taxpayer under section 17 of this chapter that
18 includes a repayment provision under subsection (a), the corporation shall include in the repayment
19 provision a provision establishing the interest rate that will be applied. The interest rate shall be
20 determined by the board and approved by the budget agency.

21 (d) This subsection applies to an active multi-phased project occurring on a defined footprint for which
22 the taxpayer has received approval for at least the first phase of the active multi-phased project from the
23 corporation's board before July 1, 2018, for a tax credit under IC 6-3.1-11 (industrial recovery tax credit)
24 before its expiration. The following apply to a project described in this subsection:

25 (1) Only qualified investments that are made after June 30, 2021, are eligible for a credit award
26 under this chapter.

46 **Sec. 2. As used in this chapter, "pass through entity" means:**

- 1 (2) a partnership;
- 2 (3) a trust;
- 3 (4) an estate;
- 4 (5) a limited liability company; or
- 5 (6) a limited liability partnership.

6 **Sec. 3.** As used in this chapter, "qualified child care expenditure" means an expenditure:

- 7 (1) for the acquisition, construction, rehabilitation, or expansion of property used as part of
- 8 an Indiana qualified child care facility of a taxpayer that is operated for the taxpayer's
- 9 employees;
- 10 (2) incurred under a contract between a taxpayer and an Indiana qualified child care facility
- 11 to provide for the acquisition, construction, rehabilitation, or expansion of property used as
- 12 part of the Indiana qualified child care facility; or
- 13 (3) for purposes of complying with the qualified child care facility licensure requirements
- 14 under IC 12-17.2, as part of the taxpayer acquiring or constructing an Indiana qualified child
- 15 care facility.

16 **Sec. 4.** As used in this chapter, "qualified expenditure" means a qualified child care expenditure.

17 **Sec. 5.** As used in this chapter, "recapture event" means:

- 18 (1) the cessation of the operation of the Indiana qualified child care facility as an Indiana
- 19 qualified child care facility;
- 20 (2) subject to section 12(c) of this chapter, a change in ownership of an Indiana qualified child
- 21 care facility for which a credit was allowed under this chapter, unless the person acquiring an
- 22 interest agrees to assume the recapture liability of the person disposing of an interest; or
- 23 (3) the use of an Indiana qualified child care facility for the enrollment of a child from any
- 24 individual who is not an employee of the taxpayer.

25 The term does not include a cessation of operation or change in ownership due to accident or

26 casualty.

27 **Sec. 6.** As used in this chapter, "state tax liability" means the taxpayer's total tax liability that

28 is incurred under:

- 29 (1) IC 6-3-1 through IC 6-3-7 (the adjusted gross income tax);
- 30 (2) IC 27-1-18-2 (the insurance premiums tax) or IC 6-8-15 (the nonprofit agricultural
- 31 organization health coverage tax); and
- 32 (3) IC 6-5.5 (the financial institutions tax);

33 as computed after the application of the credits that, under IC 6-3.1-1-2, are to be applied before

34 the credit provided by this chapter.

35 **Sec. 7.** As used in this chapter, "taxpayer" means any person, corporation, limited liability

36 company, partnership, or other entity that has any state tax liability and employs one hundred (100)

37 individuals or less. The term includes a pass through entity. However, the term does not include a

38 taxpayer who is in the business of operating a child care facility prior to making qualified

39 expenditures.

40 **Sec. 8.** (a) A taxpayer that makes a qualified expenditure in a taxable year is entitled to a credit

41 against the taxpayer's state tax liability for the taxable year.

42 (b) Subject to section 9 of this chapter, the maximum amount of the credit to which a taxpayer

43 is entitled in a particular taxable year is equal to the lesser of:

- 44 (1) fifty percent (50%) of the employer's qualified expenditures in the taxable year; or

38 (c) A recapture event is not considered to have occurred as a result of a change in ownership of
39 an Indiana qualified child care facility for which a credit was allowed under this chapter if, before
40 the change in ownership transaction is completed, the person acquiring an interest in the facility
41 agrees in writing to assume the liability of the taxpayer for any recapture amount that becomes
42 owed. In the event of such an assumption, the person acquiring the interest in the facility shall be
43 treated as the taxpayer for purposes of assessing any recapture liability that becomes owed due to
44 a subsequent recapture event, computed as if there had been no change in ownership, and is
45 responsible for payment to the department of the recapture amount.

20 Sec. 3. As used in this chapter, "credit" refers to a credit granted under this chapter.

21 Sec. 4. As used in this chapter, "pass through entity" has the meaning set forth in IC 6-3-1-35.

22 Sec. 5. As used in this chapter, "state tax liability" means a taxpayer's total tax liability that is
23 incurred under:

24 (1) IC 6-3-1 through IC 6-3-7 (the adjusted gross income tax); and

25 (2) IC 6-5.5 (the financial institutions tax);

26 as computed after the application of the credits that under IC 6-3.1-1-2 are to be applied before the
27 credit provided by this chapter.

28 Sec. 6. As used in this chapter, "taxpayer" means an individual or entity that has any state tax
29 liability.

30 Sec. 7. A taxpayer that makes a contribution to an affordable housing organization that is
31 approved under section 11 of this chapter is entitled to a credit against the taxpayer's state tax
32 liability in the taxable year in which the taxpayer makes the contribution.

33 Sec. 8. The amount of a taxpayer's credit is equal to fifty percent (50%) of the amount of the
34 contribution that is not more than twenty thousand dollars (\$20,000) made to the affordable
35 housing organization.

36 Sec. 9. (a) If the credit provided by this chapter exceeds the taxpayer's state tax liability for the
37 taxable year for which the credit is first claimed, the excess may be carried forward to succeeding
38 taxable years and used as a credit against the taxpayer's state tax liability during those taxable
39 years. Each time the credit is carried forward to a succeeding taxable year, the credit is reduced
40 by the amount that was used as a credit during the immediately preceding taxable year. The credit

43 After June 30, 2019, the new applicable rate may not exceed the rate in effect on June 30 plus two cents

1 (c) The department shall consider it a rebuttable presumption that all undyed or unmarked special fuel,
2 or both, received in Indiana is to be sold for use in propelling motor vehicles.

3 (d) Except as provided in subsection (e), the tax imposed on special fuel by subsection (a) shall be
4 measured by invoiced gallons (or diesel or gasoline gallon equivalents in the case of a special fuel
5 described in section 22.5(2) or 22.5(3) of this chapter) of nonexempt special fuel received by a licensed
6 supplier in Indiana for sale or resale in Indiana or with respect to special fuel subject to a tax precollection
7 agreement under section 35(j) of this chapter, such special fuel removed by a licensed supplier from a
8 terminal outside of Indiana for sale for export or for export to Indiana and in any case shall generally be

22 (h) A person that engages in blending fuel for taxable sale or use in Indiana is primarily liable for the

33 (6) Designing, landscaping, beautifying, or maintaining public areas.
34 (7) Activating and promoting public events.
35 (8) Creating innovative approaches to attracting new businesses.
36 (9) Supporting business development.
37 (10) Planning improvement activities.

38 **Sec. 4. (a) The legislative body of a city may adopt an ordinance establishing a special assessment**
39 **district known as the economic enhancement district. The adopting ordinance must contain the**
40 **following:**

- 41 (1) the boundaries of the proposed economic enhancement district, which may not exceed
42 the boundaries of the Mile Square area of the city;

32 used for capital expenses for the new lodge at Potato Creek State Park project.**

33 (5) **Ten million dollars (\$10,000,000) to department of natural resources to be used for the
34 President Benjamin Harrison conservation trust fund.**

35 (6) **Ten million dollars (\$10,000,000) to the department of education to be used for the Lilly
36 Endowment literacy grant state match.**

37 (7) **One billion dollars (\$1,000,000,000) to the pension stabilization fund (established by
38 IC 5-10.4-2-5) for purposes of the pre-1996 account.**

39 (8) **Two hundred fifty million dollars (\$250,000,000) to the Indiana economic development
40 corporation for the deal closing fund.**

41 (9) **Five million dollars (\$5,000,000) to the department of natural resources to be used for
42 repairs at McCormick's Creek State Park campground.**

43 (10) **Fifteen million dollars (\$15,000,000) to Purdue University Fort Wayne for the school of
44 music building.**

45 (11) **Sixty million dollars (\$60,000,000) to Indiana University for the school of science
46 instructional and research building.**

1 (12) Sixty million dollars (\$60,000,000) to Purdue University for the academic and student
2 success building.

3 (13) Eighty-one million six hundred thousand dollars (\$81,600,000) to Ball State University to
4 be used for north campus building renovations.

5 (14) Sixty-six million dollars (\$66,000,000) to Indiana State University to be used for the center
6 for technology, engineering, and design.

7 (15) Eighty-nine million five hundred thousand dollars (\$89,500,000) to Indiana University to
8 be used for the Wells Quad and public health building renovation.

9 (16) Thirty-three million one thousand four hundred fifty dollars (\$33,001,450) to Ivy Tech
10 Community College to be used for the Indianapolis campus restructure.

38 revenue that would otherwise be deposited in the Indiana homeland security fund on or after June
39 30, 2023, shall be deposited in the regional public safety training fund established by IC 10-19-9.1-1,
40 as added by this act.

41 (b) Any balance in the fire training infrastructure fund established by IC 22-14-6-2, as repealed
42 by this act, shall be transferred to the regional public safety training fund established by
43 IC 10-19-9.1-1, as added by this act, on June 30, 2023.

29 SECTION 302. [EFFECTIVE UPON PASSAGE] (a) As used in this SECTION, "task force" refers
30 to the funding Indiana's roads for a stronger, safer tomorrow task force established by subsection
31 (b).

32 (b) The funding Indiana's roads for a stronger, safer tomorrow task force is established.

33 (c) The task force consists of the following members:

34 (1) The chairperson of the house of representatives ways and means committee.

35 (2) The chairperson of the senate appropriations committee.

36 (3) The chairperson of the senate tax and fiscal policy committee.

37 (4) The chairperson of the house of representatives roads and transportation committee.

38 (5) The chairperson of the senate homeland security and transportation committee.

39 (6) The director of the office of management and budget.

40 (7) The public finance director of the Indiana finance authority.

41 (8) One (1) member who represents counties and is appointed by the governor after
42 considering the recommendation of the Association of Indiana Counties.

43 (9) One (1) member who represents municipalities and is appointed by the governor after
44 considering the recommendation of Accelerate Indiana Municipalities.

45 (10) One (1) member appointed by the governor after considering the recommendation of the
46 Build Indiana Council.

1 (11) One (1) member appointed by the governor who is an employee of the Indiana department
2 of transportation.

3 (12) One (1) member appointed by the governor who is a member of the Indiana Motor Truck
4 Association.

5 (13) One (1) member appointed by the governor who represents taxpayers.

6 (14) One (1) member of the general assembly who is a member of the majority party of the
7 house of representatives and is appointed by the speaker of the house of representatives.

8 (15) One (1) member of the general assembly who is a member of the minority party of the
9 house of representatives and is appointed by the speaker of the house of representatives in
10 consultation with the minority leader of the house of representatives.

11 (16) One (1) member of the general assembly who is a member of the minority party of the
12 senate and is appointed by the president pro tempore of the senate in consultation with the
13 minority leader of the senate.

14 (d) The budget committee shall select a member of the task force to serve as the chairperson of
15 the task force.

16 (e) The task force shall do the following:

17 (1) Review state highway and major bridge needs.

18 (2) Verify road and bridge needs at the local level.

19 (3) Develop a long term plan for state highway and major bridge needs that addresses the ten
20 (10) points described in subsection (g) and:

21 (A) will achieve the recommended pavement and bridge conditions;

22 (B) will complete the current statewide priority projects by finishing projects that have
23 been started;

24 (C) includes Tier 1, 2, and 3 projects; and

25 (D) using the model developed by the Indiana department of transportation, includes
26 sustainable funding mechanisms for the various components of the plan.

27 (4) Review the long term impact of electric and hybrid vehicles.

28 (5) Develop a long term plan for local road and bridge needs.

29 (f) The long term plan for state highway and major bridge needs must provide a basis for
30 consideration for the state biennial budget enacted for the biennium beginning July 1, 2025.

31 (g) The long term plan for state highway and major bridge needs must include the following ten
32 (10) points:

33 (1) Estimates of the costs of major projects, including a study of which projects can be done
34 within current revenue streams and which projects may require additional funding.

35 (2) The identification of projects for which a public-private partnership, a public-private
36 agreement, or tolling might be viable, with planning to verify and confirm these public-private
37 partnership, public-private agreement, or tolling opportunities.

38 (3) The identification of resources for annual maintenance needs, concentrating first on
39 available user fees and attempting to secure stable and predictable funding sources. This must
40 include a determination of whether additional resources must be pursued and what form of
41 resource is most appropriate for each project.

42 (4) A review of the state's debt situation and the development of a plan to maintain a strong
43 financial position for the state. This must include consideration of whether a fee or tax could
44 be associated with the life of a bond for an individual project, with the fee or tax then expiring
45 by law upon payment of the bond.

- 1 **(5) The evaluation of the state system of taxes, fees, and registration fees, and the equity of**
- 2 **payments by different groups of users of transportation assets. This must include an evaluation**
- 3 **of the overall reliability over time of the receipt of revenue from these sources.**
- 4 **(6) A review of the fuel tax system, including such concepts as indexing tax rates, changing tax**
- 5 **rates, and the appropriate collection points for these taxes.**
- 6 **(7) The ensuring that the projects listed in the plan are priority items that should be carried**
- 7 **out, and confirming that these projects bring value to citizens either through access and safety**
- 8 **needs or for economic development of Indiana as a whole.**
- 9 **(8) A review of the impact and advisability of dedicating some part of state sales tax to roads**
- 10 **and road maintenance.**
- 11 **(9) An analysis of how collective purchasing agreements could be developed to share and**
- 12 **reduce costs across the system of state and local governments.**
- 13 **(10) A presentation of the plan and recommendations to the budget committee before January**
- 14 **1, 2024.**
- 15 **(h) The legislative services agency shall provide staff support to the task force.**
- 16 **(i) The meetings of the task force must be held in public as provided under IC 5-14-1.5. However,**
- 17 **the task force is permitted to meet in executive session as determined necessary by the chairperson**
- 18 **of the task force.**
- 19 **(j) This SECTION expires June 30, 2024.**
- 20 **SECTION 303. An emergency is declared for this act.**
